What Qualifies A Contract As Illegal.



Illegal Deposits

Deposits taken on Timeshare products within 10 days of contract signature.



Floating Contracts

Contracts containing 'floating' weeks that do not designate a date range and unit number.



Perpetuity Clauses

Contracts that contain 'perpetuity' clauses that exceed a 50 year maximum length.



Misrepresentation

Contracts that were signed on the basis of verbal promises that never came to fruition.

Frequently Asked Questions.



#01

Does this apply to Timeshare purchased anywhere in the world?

No, only Timeshares bought from resorts within the ECC/Spain. However CLA International FZE provide other Timeshare exit solutions for purchases made around the world.

> How do I know if I am eligible to claim?

#02

If you bought your Timeshare in Spain, directly from the Developer (not a resale) and it was purchased after 1999 then you will almost certainly be eligible to claim. Please contact us to confirm your claim.

#03

What are your fees?

An initial fee is established from the outset of your case and is relative to the volume of your claim. This initial fee covers lawyers' costs, the cost of translating all your documents into Spanish and any other third party costs which we may need to incur on your behalf. We will add this initial fee to the amount we are claiming. Once your case has come to a successful conclusion we charge a success fee as a percentage of the total amount recuperated.

Can I still use my Timeshare if I launch a claim?

#04

As long as you continue to pay your maintenance fees then your membership rights will remain unaffected by any legal action.

#05

How much money will be refunded back to me?

This will depend on your individual case but our lawyers will request a full refund of the amounts paid for your Timeshare, full repayment of all legal fees plus they will seek to claim other compensation such as double the value of the deposit, maintenance payments and indemnisation for other losses.

TIMESHARE HORRORS: HOPE FOR 100,000

Thousands of Britons trapped in onerous timeshare or "holiday club" arrangements – where they are forced to pay annual fees for few or no benefits – could be given an escape route as their contracts are effectively "null and void". Some might even be able to claim refunds. These rip-off agreements could completely unravel as a result of a court ruling against "perpetual" timeshares. Soon-to-beimplemented Europe-wide rules are expected to back the decision.

Figures from the timeshare industry show that around 12pc of the 850,000 timeshares in Europe could now be considered illegal and their owners due a refund of all money spent, plus interest and legal costs.

8 SENTENCES ANNUL 400,000 € OF TIMESHARE.

The Civil Chamber of the Supreme Court has issued in just ten days, a total of eight judgments against the company Silverpoint Vacations for irregularities in the sale of tourist accommodation weeks in the south of Tenerife.

The result of these cases has culminated in the court mandating that Silverpoint return more than 450,000 euros to customers.

According to the law firm Canarian Legal Alliance, which represents the plaintiffs, the company has accumulated 18 Supreme Court judgments against it so far this year.

Unlike more traditional

timeshare , the formula marketed by Silverpoint Vacations is based on membership in a club that gives buyers not only an annual holiday entitlement, but also the possibility of obtaining an economic return through the resale of that right after two years.
